## 1. Product content / compliance

- 1 x 10<sup>7</sup> cfu/ml Trichoderma Harzianum spp.
- 1 x 10<sup>7</sup> cfu/ml Trichoderma Konigii
- 1 x 10<sup>8</sup> cfu/ml Azotobacter chroocorum
- 1 x 10<sup>8</sup> cfu/ml Azospirillum lipoferum

## 2. Physical/chemical properties

**COUNTRY 600** comes in liquid state, has a brown color, with a specific smell.

## 3. Action mode / Description

COUNTRY 600 is a biodynamic product, obtained by a process of rapid cold fermentation of organic matter and its mixing with NON-GMO organic and mineral substances that complies with the requirements of Regulation 889/2008, Annexes I and II.

100% natural organic foliar treatment which contributes to the degradation of the vegetal matter remained after the harvest up to 600 times faster.

The use of COUNTRY 600 significantly reduces the risk of transmitting diseases and pests and brings a spectacular intake of nutrients to the soil.

At the same time, if it is applied on dry vegetation immediately after the harvest (on the vegetation leftovers remaining after the harvest), COUNTRY 600 will significantly decrease the risk of diseases and pest transmission and will bring a spectacular contribution of nutritional substances in the ground for the future crops.

## 5. Recommended dosage

From practical experience and / or available documentation, we recommend the following application dosage:

### ALL TYPES OF CROPS

3L / ha, in 200 – 400 liters of water, directly applied on dry vegetation immediately after the harvest (on the vegetation leftovers remaining after the harvest), **OR**

3L / ha, in 200 – 400 liters of water, before sowing / planting, when preparing the seedbed or by fertigation in the case of already established crops
