The management of Norofert S.A., hereinafter referred to as “Company”, informs the market and the bondholders that on **July 27<sup>th</sup>, 2021**, the payment of the third coupon for corporate bonds issuance, traded on Bonds-SMT market with NRF25 symbol, will take place.

The payment will be made through the Central Depository and BRD - GROUPE SOCIETE GENERALE S.A. as the Paying Agent to the bondholders registered in the Bondholders Registry at the reference date of **July 13<sup>th</sup>, 2021**.

The coupon will be paid via bank transfer directly to the accounts of all participants in the RoClear System, to the bondholders’ bank accounts which were confirmed by the bondholders in the Subscription Form, or to the bank accounts which were notified to the Payment Agent by the bondholders.

Norofert S.A.’s corporate bonds are tradeable on the Bonds-SMT Market, administered by the Bucharest Stock Exchange as of June 5<sup>th</sup>, 2020, under the NRF25 ticker. The interest rate is fixed at 8,5% per year and the interest amount is **4,2151 lei gross per bond**. The coupons are paid semi-annually on the Coupon Payment Date.
