Action Mode:

Amino acids support the maintenance, growth, vitality and reproduction of plants. The product gives plants more energy) and more stamina, for an improved plant and produces



color, bigger leaves, longer roots, more flowers, more and/or bigger fruits and a generally healthier culture. Potassium plays a very important role in protein formation and flowering. It allows the formation of sugars resulting in quality production. Potassium contributes to improved plant development, more abundant and greener growth, increased production and better crop quality.

How to use:

The product is recommended to be used for the ripening (fruiting) phase of fruit trees and vegetables. The recommended dose is a 1% solution (100 ml in 10 l water) applied foliarly 2-3 treatments after fruit formation, or by drip 3-4 treatments at an interval of 7 days with 2% (100 ml in 5 l water).

Hygiene measures and labor protect:

Avoid contact with skin, eyes and clothing. Use personal protective clothing. Hands and/or face should be washed before breaks and at the end of work hours.

First aid measures:

- after inhalation: rest, fresh air, medical care.
- After skin contact: Wash immediately with plenty of soap and water. If the irritation persists, a doctor will be called.
- after eye contact: wash the affected eyes with the eyelids open for at least 15 minutes under the current of water.
- after ingestion: no vomiting will be induced. It will rinse your mouth very well. A doctor will be notified immediately.

Indications for the doctor: No specific antidote is known. It will be treated symptomatically.

Environmental protection measures :

Do not unload on the ground/in the basement. Do not drain into drainage channels/surface waters/groundwater. Prevent the product from reaching surface waters by any measure.

Storage and transport conditions :

Store in a dry, cool and well-ventilated place accessible only to authorized personnel. It will be protected from direct sun exposure and will protect from frost. Storage temperature 5° C – 25° C.

Validity period: Two years from the date of manufacture.
